## Social Health for Everyone: **Sharing SONNET survey** results at national SDOH symposium

On August 11, Anand Shah and Meagan Brown will give the closing keynote at Modern Healthcare's 2022 Social Determinants of Health Symposium

Modern Healthcare's 2022 Social Determinants of Health Symposium brings together providers, payers, and other stakeholders who are working to address systemic inequities that impact community health. Held virtually on August 11, this event features expert perspectives on the close relationship between social determinants of health and health outcomes, as well as insights on strategies to advance community health.

In the event's closing keynote session, entitled "Social Health for Everyone," SONNET Evaluation and Research Committee (ERC) member Meagan Brown, PhD, will present results of recent SONNET-led research that sheds light on the prevalence of social needs among KP members. KP Vice President of Social Health and SONNET executive sponsor, Anand Shah, MD, MS, will discuss health care's important role in addressing social needs and how KP is advancing its social health practice to better serve members.

## **Interventions Addressing Social Isolation and Loneliness: A Rapid Evidence Review**

New SONNET report offers insights into effective interventions for 3 key populations

SONNET's latest report from our Evaluation and Research Committee (ERC) focuses on social isolation and loneliness

in 3 key populations: older adults, teens/young adults, and people who are pregnant or postpartum. ERC member Nancy Weinfield, PhD, and her colleague Adrienne Deneal, MS, at KP Mid-Atlantic Permanente Research Institute, led a rapid evidence

review of interventions for social isolation and loneliness in these 3 populations. Their report offers different "pathways forward" for each group, for example:

- Older adults: Interventions that promote group activity show promise for older adults who are physically active - while visitor and virtual approaches may be more effective for those who have limited mobility.
- Teens/young adults: Mindfulness seems to be successful approach but more research is needed to understand the impact of unaddressed mental health needs
- · People who are pregnant or post-partum: The existing intervention literature seems to frame loneliness and social isolation as mechanisms that influence other outcomes, such as parenting or depression. More research is needed within this population to understand loneliness and social isolation as specific outcomes.

#### State of the Science on Social Screening in Healthcare Settings: New report from our partners at SIREN

The Social Interventions Research and Evaluation Network (SIREN) recently released a new report that synthesizes existing research on social screening in U.S. health care. Funded by the Robert Wood Johnson Foundation, the report aims to inform and intensify the national dialogue about social risk screening. Findings are summarized in 5 digestible sections: prevalence of screening, validity of existing screening tools, patients'



perspectives on screening, providers' perspectives on screening, and screening implementation.

#### ROI Calculator for Partnerships to Address SDOH: A tool to help show the value of integrating social services with medical care

If you're looking for a tool to help understand the return on investment (ROI) from integrating social services with medical care, check out the ROI Calculator for Partnerships to Address the Social Determinants of Health. The calculator was designed for health systems, payers, medical providers, social service providers, and community-based organizations (CBOs) who are working to address social determinants of health. It was created by The Commonwealth Fund to help CBOs and their health care partners create sustainable financial plans for delivering social services to patients with complex health care needs.

#### Funding opportunity: Stimulating Research to Understand and Address Hunger, Food, and Nutrition Insecurity

In June, the National Institutes of Health released a new Notice of Special Interest (NOSI) related to research on hunger, food, and nutrition insecurity. The purpose of this NOSI is to encourage research on the efficacy of interventions that address nutrition security and the mechanisms of food insecurity on a variety of health outcomes. It also calls for the development of new measures for nutrition security and assessment of food insecurity that are broadly applicable.
