CESR: Social Needs Patient Reported Outcomes Surveys Added to the VDW

What's going on?

The Center for Effectiveness and Safety Research (CESR) project, funded by Kaiser Permanente (KP), added two new social needs assessments to the Patient Reported Outcomes (PRO) tables in the CESR Virtual Data Warehouse (VDW).

- The Medicare Total Health Assessment (MTHA) Became part of clinical care across many KP regions in 2012
- 2. **The Your Current Life Situation (YCLS)** Multi-regional pilot testing began in 2016 for specific programs (see tables below)

Why is this important?

Data is easier for researchers to access - Both assessments have been compiled into the CESR VDW tables. Previously, researchers wanting access to these data, searched multiple places, making it challenging to extract and organize the data. For example, in Clarity they examined questionnaire data, flowsheets and smart data elements (or smart data forms). In other instances, they may have contacted outside vendors (e.g., PTI). Finding all data sources

remains an ongoing challenge, so our CESR team partners with researchers across all regions and KP Operations to make these data as complete as possible.

The PRO tables include data for each survey administered, with variables such as:

- **Type of survey:** (YCLS, MTHA, PHQ9 (Patient Health Questionnaire, a depression screener), AUDIT (Alcohol Use Disorders Identification Test), GAD (Generalized Anxiety Disorder screener), etc.)
- **Question:** (e.g., In the past 3 months, how often have you worried that your food would run out before you had money to buy more?)
- **Response:** (e.g., Never, Sometimes, Often, Very Often)
- **Medical Record Number and Encounter ID:** gives users the ability to link to other VDW data (e.g., office visits, dispensings, diagnoses, etc.)
- **Survey mode:** (e.g., telephone, office visit, mail, web, etc.)

What can we expect?

Enhancing the social needs data in the VDW - Additional activities in 2018 are enhancing the social needs data in the VDW. A feasibility assessment survey was sent to each region's lead VDW data manager to determine other potential sources for these data. Some examples of these sources include:

- CESR PRO data: AUDIT data may include important related social needs information.
 The PHQ9 includes data for Kaiser Permanente patients who might be suffering from depression.
- **VDW Diagnosis and Procedure data:** Specific social needs diagnosis and procedure codes are being used in HealthConnect. These data are pulled into the VDW via the Diagnosis and Procedures tables.
- **Clarity Clinical Terms:** Providers enter clinical terms and they are cross walked into diagnosis codes. These clinical terms can have greater detail than a diagnosis code.

Researchers at the Center for Health Research (KPNW) believe that the PRO data we have captured is a great resource, although we continue to find additional sources that identify more patients with social needs. These include ICD-9 (v codes) and ICD-10 (z codes) which have been used for social needs diagnosis. Collectively, the use of PRO and ICD data enables KP researchers to assess social needs of KP members, as well as include these data in analyses, providing a rich and unique data source that is available at few other research institutions.
